### 2024 IRIS Award in Veterinary Nephrology

The International Renal Interest Society (IRIS)\* is pleased to invite nominations or applications for the 2024 IRIS Award. IRIS is an international organization that aims to advance veterinary nephrology and to help veterinary practitioners better diagnose, understand and treat kidney disease in cats and dogs. The IRIS Award (Value: EURO 10,000) is granted to an individual early in his/her research career for outstanding fundamental or clinical research performed in veterinary nephrology.

#### Qualifications:

Candidates for the IRIS Award must:

- be a veterinarian
- be in an early stage of career development, actively engaged in the field of veterinary nephrology for less than 7 years\*\*
- have recently conducted research project(s) that have contributed significantly to the understanding, diagnosis, and/or treatment of kidney disease in dogs and/or cats.
- have research contributions published or accepted for publication in peer reviewed journals within the last 5 years (earliest publication date for consideration is 2016).

#### Nomination/Application Process:

nominations/applications will be reviewed and judged independently by individual members the IRIS Board. The results will be announced on or before Feb 1,2024.

**Use of the Award:**

The award funds may be used to support any clinically-relevant research in small animal nephrology, at the total discretion of the recipient. It is the responsibility of the recipient to ensure that appropriate ethical approval is in place before any work that involves living animals. The award is usually paid into a university-held and administered account, however if the successful applicant is not based in a university then consideration would be given to other legitimate means of administering the funds that provides the IRIS Board with confidence that the funds will be used for the purpose they are intended. The money cannot be paid into a privately held bank-account.
